


How to: register as an administrator for our ECDIS **Training Assessment (ETA)**

Important note: to invite users to NorthStandard's ECDIS Training Assessment tool, you will need to have a MyNorth account. Follow the instructions in the How to: register to MyNorth guide: https://www.nepia.com/publications/how-to-register-to-mynorth/

2. Hover over 'MyNorth' in the main navigation and complete your account details (email address and password) from the login field, then click 'login'.













3. Once you are logged in to MyNorth, navigate to the 'My Apps' link from the dropdown menu bar, then click on the heading 'My Apps'.











5. Complete the fields, entering your first name, last name, and email address.
